 FedEx Declared Value Exception Program Information**

1. In order to qualify for FedEx Declared Value Exception, you must meet certain requirements. You will be contacted by FedEx to complete program enrollment. If you qualify for FedEx Declared Value Exception, a contract will be mailed to you for review and signature. **Please review the contract terms carefully before you sign the agreement. Your FedEx Declared Value Exception coverage and shipping discounts are not in effect until FedEx processes the fully executed contract.**
2. FedEx Declared Value Exception offers eligible shippers the opportunity to declare values above the standard FedEx contract of carriage using the following services: FedEx Priority Overnight®, FedEx Standard Overnight®, FedEx 2Day®, FedEx International Priority® and FedEx International Economy®.
3. FedEx Declared Value Exception is only available for shipping within the U.S. and to select FedEx direct-served international countries. The full list is available at [fedex.com/us/services/options/dvx/countriesserved.html](http://fedex.com/us/services/options/dvx/countriesserved.html).
4. Declared value limits vary by service and international destination.
5. FedEx Declared Value Exception packages have specific drop-off requirements. Your FedEx account executive or FedEx Declared Value Exception representative will assist you.
6. The FedEx Declared Value Exception does not apply to FedEx Ground® shipments.
