The Jewelers of America mission is to increase consumer confidence in the jewelry industry by advocating professionalism and adherence to high ethical, social and environmental standards. The Code of Professional Practices establishes the standards our members enthusiastically endorse in theory and practice. Members encourage these practices within their “spheres of influence” – supply-chain relationships, the wider jewelry industry and the world in which the member and their business partners operate.

ETHICAL PRACTICES

- We will fully and accurately disclose the material characteristics of the products and merchandise we sell.
- We will take reasonable measures to ensure the physical integrity and security of product shipments.
- We will respect commercial confidentiality and the data privacy of our employees, business partners and customers.
- We will strive to continuously improve our professionalism and expertise, as individuals and as a company.
